# 1. P&P #136: Information Technology Resources

Chief Teran requested approval of P&P #136: Information Technology Resources. This policy establishes the roles and responsibilities for the use of Department information technology and defines standards of use to all owned, leased, on-site or off-site Department IT resources. Commissioner von Ibsch moved to approve P&P #136 as presented. Commissioner Carey seconded the motion and the motion passed unanimously.

#### 2. P&P #151: IT Equipment Replacement

Chief Teran requested approval of P&P #151: IT Equipment Replacement. This policy provides an outline of how and when Department owned computer hardware should be replaced to avoid service interruptions. It mandates that an equipment replacement schedule be maintained for use in strategic and budget planning. Commissioner von lbsch moved to approve P&P #151 as presented. Commissioner Carey seconded the motion and the motion passed unanimously.

- 3. Resolution #04-2022: 2023 Property Tax Revenue General Fire Levy Chief Teran requested approval of Resolution #04-2022: 2023 Property Tax Revenue General Fire Levy. This resolution authorizes the increase of the General Fire Levy collected in 2023 by 1.0%. Commissioner Carey moved to approve Resolution #04-2022 as presented. Commissioner von Ibsch seconded the motion and the motion passed unanimously.
- 4. Resolution #05-2022: 2023 Property Tax Revenue EMS Levy Chief Teran requested approval of Resolution #05-2022: 2023 Property Tax Revenue EMS Levy. This resolution authorizes the increase of the EMS Levy collected in 2023 by 1.0%. Commissioner Carey moved to approve Resolution #05-2022 as presented. Commissioner Chymiy seconded the motion and the motion passed unanimously.
- 5. Resolution #06-2022: 2023 Budget
  Chief Teran requested approval of Resolution #06-2022: 2023 Budget. This resolution establishes the Department's operating budget in 2023. The budget includes an operating surplus of \$112,831 in 2023, consistent with the Department's 10-year financial projections. Commissioner Carey moved to approve Resolution #06-2022 as presented. Commissioner Isenman seconded the motion and the motion passed unanimously.
