### FIRE CHIEF'S REPORT

- Audit update: Finance Manager Kaufman briefed the Board on the Audit Exit Conference held on December 15<sup>th</sup> and the final 2020/2021 Audit Report. There were no findings and only minor recommendations from the State Auditor's Office. Commissioner Chymiy represented the Board at the Exit Conference.
- Financial update: Finance Manager Kaufman provided a preliminary 2022 financial report to the Board. Overall, revenue exceeded expenses in 2023 by \$1,330,278 which exceeded original 2022 budget projections by \$715,000.
- Holiday Truck summary: Chief Teran briefed the Board on Department activities with the Holiday Truck in December. The Department received many compliments for continuing this holiday tradition.
- 2023 Legislative event in Olympia: Chief Teran noted the upcoming Legislative Day to be held in Olympia on February 17<sup>th</sup>. DC Moravec will be attending the event.
- Kitsap County Fire Commissioner presentation: The KCFCA has asked DC Moravec to provide a presentation on January 24<sup>th</sup> regarding the COVID-19 vaccination clinic effort on Bainbridge Island over the last two years.

### GOOD OF THE ORDER

Commissioner Carey noted a survey that he received from Kitsap 911 regarding hazardous material at commercial businesses.

Commissioner Chymiy inquired about BIFD responses during the recent ice storm.

Commissioner Rosenberg mentioned that he is very impressed with the representative from Prothman, the firm leading the search for the new Deputy Chief.
