### FIRE CHIEF'S REPORT

- Fire station construction update: Construction Project Manager Charlie Demming provided an update on the station construction project including the following:
  - > Site utilities, sewer & storm drain installation for Station 22 is almost complete.
  - > Grading for pavement has begun.
  - > Framing is continuing.
  - > Washington Water service was established August 27.
  - > Final inspection correction list for Station 21 is being prepared.
  - > Final items on COBI's punch list are being addressed.
- Lieutenant promotion: A ceremony for Justin Foley, recently promoted to Lieutenant, will be held on September 26 at 5:30 PM.
- Lateral firefighter update: DC Moravec reported that the testing process for lateral firefighter hires will be completed on September 6 with interviews.
- Senator Rolfes Station 21 tour: Chief Teran has invited Senator Rolfes, as well as other local elected officials, to tour Station 21 on September 19 at 2:00 PM.
- Fire Chief continuing education: Chief Teran requested and received support of the Board for his continuing education classes in emergency management.
- New Kitsap County MPD: Chief Teran announced that Dr. Hoffman has been appointed as the new Kitsap County Medical Program Director.
- Medical Services Officer (MSO): Chief Teran briefed the Board on the hiring of a part-time medical services administrator who will evaluate the Department's need for a fulltime, permanent MSO. Former BIFD paramedic, Dave Coatsworth, will fill this position on a temporary basis.
- Commissioner Training September 19<sup>th</sup>: Following the BOC meeting on September 19, Commissioners are invited to attend a training session on High Performance CPR.
- Fire Chief/Commissioner Calendar: An updated version of the Fire Chief-Commissioner Calendar will be sent to the Board by the end of this week.
